<p><u>Visit our School Improvement Plan. Are these things happening, and how?</u></p> <p>1. To provide successful educational opportunities for students who are unable to access their assigned schools due to behaviors impacting their academics.</p> <p>*What is the process to ask for additional SMARTboards for next year? What about another laptop cart? Wait until after July 1 to look at</p> <p>*Pooling TSI Funds with Other Schools- As a school, do we approve the potential decision to pool TSI funds with one or more schools with identical subgroup identifications to for PD or evidence based resources to support that subgroup? State has changed SIT plan process. When certain subgroups do not meet expectations, we need to have an intervention plan. For us this is EC population. District has recommended a math/reading program. Training will take place throughout the next school year. EC kids from all schools should have access to this program.</p> <p>2. To increase student self-regulation strategies and skills to decrease behaviors impacting student learning.</p> <p>*Discussing exit criteria/exit projects in SEL Self reflection, routine, give Roe bucks, focusing on good decision making, remind about exit criteria in SEL lessons, SEL journals prepare for exit projects, remind about 30 day verbal/physical aggression</p> <p>3. To establish a safe learning environment where learning occurs and is respectful of cultural diversity.</p>		10
